SECTION 1. WITHDRAWAL OF THE AUTHORITY OF VICE MAYOR RAUL R. SABANGAN TO COUNTERSIGN CHECKS. The authority given to Vice Mayor Raul R. Sabangan to countersign checks is hereby withdrawn. All checks duly drawn by the Municipal Treasurer shall be countersigned by the Municipal Administrator and the Municipal Mayor, as the case may be.

SECTION 2. REPEALING CLAUSE. All other orders, rules, regulations and issuances, or parts thereof, which are inconsistent with this Order, are hereby repealed, amended or modified accordingly.

SECTION 3. EFFECTIVITY. This Executive Order shall take effect immediately.
