EXECUTIVE ORDER No. 39 Series of 2020

AN ORDER AMENDING THE REGULATIONS ON THE ACCESS TO THE BAYAMBANG PUBLIC MARKET, GROCERY STORES AND SUPERMARKETS IN THE MUNICIPALITY OF BAYAMBANG

WHEREAS, President Rodrigo Roa Duterte issued Proclamation No. 922 on March 08, 2020 declaring a State of Public Health Emergency, pronouncing that the CoViD-19 pandemic constitutes an emergency that threatens national security which requires a whole-of-government response aligned with the framework of the Department of Health and the efforts of all concerned government agencies and local government units. The State of Public Health Emergency remains in full force and effect until lifted or withdrawn by the President;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991 states that, "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, Memorandum Circular No. 2020- from Department of Interior and Local Government Secretary Eduardo M. Año laid down the "Suppletory Guidelines on the Implementation of Enhanced Community Quarantine in Luzon, and State of Public Health Emergency in Other Parts of the Country due to the CoViD-19 Threat. 5.1.1 of the Guidelines states that "All LGUs are charged with the promotion of health and safety within their jurisdiction. As such, they are to take the lead in the prevention and control of the spread of CoViD-19 at the local level.";

WHEREAS, under the "New Normal", the community quarantine will be lifted and minimum health standards shall be observed such as physical distancing, wearing of

facemasks and limitation of travel only for school, work, access to basic necessities, availment of basic services and exercise essential activities;

WHEREAS, despite government interventions, the number of confirmed cases of CoViD-19 continues to rise;

WHEREAS, one of the threats in the rise in the number of CoViD cases is the influx of grocers and market goers in the public market specifically the non-observance of social distancing and the sheer number of individuals going to and from the essential establishments;

WHEREAS, to fully implement the minimum health standards and strictly implement physical distancing, there is a need to limit the number of market goers going to the Bayambang Public Market;

WHEREAS, upon the recommendation of the Bayambang Anti-CoViD-19 Task Force, the schedule of market day for each barangay in the Municipality and the neighboring towns be revoked with certain conditions and was duly approved;

NOW THEREFORE, I, DR. CEZAR T. QUIAMBAO, by virtue of the powers vested in me by law as the Municipal Mayor, do hereby promulgate the AMENDMENT TO THE REGULATIONS ON THE ACCESS TO THE BAYAMBANG PUBLIC MARKET AND GROCERY STORES AND SUPERMARKETS IN THE MUNICIPALITY OF BAYAMBANG, TO WIT:

SECTION 1. BAYAMBANG PUBLIC MARKET OPERATION HOURS. The Bayambang Public Market shall continue to be open from 5AM to 7PM every day starting July 1, 2020. Provided, however, that the Public Market shall close operation on June 30, 2020 for Cleaning, Marking, Decontamination and Inspection from 5AM to 11:59PM.

SECTION 2. REVOCATION OF THE DAILY SCHEDULE OF BARANGAY RESIDENTS' ACCESS TO THE PUBLIC MARKET. The previously established Public Market Schedule per barangay is hereby revoked. The schedule of the operation of tricycle drivers and operators is also hereby revoked;

SECTION 3. MARKET SAFETY. The number of people to be allowed inside the Public Market shall be determined by the Market Administration in line with the practice of physical distancing. All three (3) entrances of the Public Market must have foot baths, and everyone who enters must undergo thermal scanning. The disinfection area in the Tricycle Terminal shall be removed.

SECTION 4. SOCIAL DISTANCING PROTOCOL. The Market and POSO enforcers, with the help of the PNP, are hereby directed to strictly implement the social distancing of at least one (1) meter in distance among market goers. To avoid decongestion, the Market Supervisor, grocery and supermarket managers are hereby directed to strategize, formulate and enforce additional social distancing protocol based on the ground observation of their establishments and have them posted for the purpose upon approval of the Local Chief Executive.

SECTION 5. NO PARKING ZONES. Starting July 1, 2020, vehicle parking along the stretch of Rizal Avenue from the Royal Supermarket to the Mercury Drugstore **SHALL NOT BE ALLOWED** from 8AM to 8PM. Market goers may only be dropped off/picked up on the designated areas accordingly;

SECTION 6. DESIGNATION OF BAGSAKAN AREAS. In order to decongest the Public Market, there shall be Bagsakan Areas for fish and vegetables starting July 1, 2020. The Bayambang Tricycle Terminal is hereby designated as the bagsakan area for vegetables. The Pay Parking Area in front of the Municipal Plaza facing the Public Market Block II (Royal Supermarket) will be the bagsakan area for fish products. The Bagsakan area may only be allowed until 7AM, provided that no Retail selling shall be allowed.

SECTION 7. DESIGNATED PAY PARKING AREAS AND OTHER PARKING AREAS. The above-mentioned pay parking area shall only be used by delivery trucks from 8AM to 8PM. Private vehicles may be parked at the designated parking spaces outside the premises of the Public Market.

SECTION 8. BICYCLE PARKING AREAS. The Market Supervisor, POSO and the Municipal Engineer are hereby directed to plan, identify and designate, after approval by the Chief Executive, a BICYCLE PARKING AREA complete with bicycle racks where bicycles may be chained by the riders.

SECTION 9. MEAT AND MEAT PRODUCTS. Meat and meat products shall be delivered using tricycles or utility tricycle (garong) inside Block III of the Public Market. Other delivery vehicles used to transport meat and meat products shall only be allowed at the bagsakan are which shall be manned by the Market staff, in coordination with the PNP.

SECTION 10. STREET PARKING. Single-lane parking may be allowed along the stretch of Quezon Boulevard from the Municipal Annex Building up to the Bayambang Public Cemetery. The Municipal Engineering Office is hereby directed to place pavement markings on the designated parking spaces. Quezon Boulevard from the corner of M.H. del Pilar Street up to Juan Luna St. may be used for single lane parking provided that driveways of residents shall not be blocked. The POSO, in

coordination with the respective Barangay Councils, shall manage the designated street parking areas.

SECTION 11. MONITORING. The Market Supervisor, POSO, MDRRMO and with the help of the PNP, shall monitoring the implementation of the physical distancing in the Public Market. The Market Supervisor is hereby directed to designate counter areas and install additional Closed Circuit TV cameras for monitoring. The said Offices are directed to provide daily reports to the Local Chief Executive thru the Office of the Municipal Administrator not later than 10 o'clock on the next day.

SECTION 12. VIOLATIONS. In the event that any person refuses to abide with or violates these guidelines, the Market and POSO enforcers are to request the assistance of the Philippine National Police officers who shall effect warrantless arrest, if warranted, on the ground of Disobedience or Resistance to Agents of Persons in Authority and file the appropriate charges

SECTION 13. SEPARABILITY CLAUSE. If any provision of the Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

SECTION 14. REPEALING CLAUSE. All other orders, rules, regulations and issuances, or parts thereof, which are inconsistent with this Order, are hereby repealed, amended or modified accordingly.

SECTION 15. EFFECTIVITY CLAUSE. This Executive Order shall take effect immediately and shall remain in effect during the State of Public Health Emergency unless sooner revoked or amended.

Let copies of this Order be furnished to Offices and Departments concerned including but not limited to, the DILG and Inter Agency Task Force, the Philippine National Police and all Barangays for their information and guidance. Further, let copies of this Order be furnished to the neighboring Municipalities for their information and appropriate action.
