## **EXECUTIVE ORDER NO. 49**

## "DELEGATION OF AUTHORITY RELATIVE TO CONDUCT SHOPPING AND SMALL VALUE PROCUREMENT AND AWARDING OF CONTRACTS THEREFOR"

**WHEREAS,** as provided under Item J of the General Guidelines of Annex "H" of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act" and to efficiently and expeditiously deal with the urgent requirements sought by these modes of procurement, there is a need to delegate the authority relative to the Conduct of Shopping and Small Value.

**NOW, THEREFORE, I, DR. CEZAR T. QUIAMBAO**, Municipal Mayor of the Municipality of Bayambang, Province of Pangasinan, by virtue of powers vested in me by law, do hereby order:

SECTION 1. DELEGATION OF AUTHORITY TO HEAD, BAC SECRETARIAT. The Head, Bids and Awards Committee (BAC) Secretariat is delegated the authority to conduct shopping and small value procurement for items with approved budget for the contract (ABC) of Php 5,001 to Php 49,999, and award contracts for procurement with same ABC procured through Shopping under Section 52.1(a) of the 2016 RIRR of RA 9184.

SECTION 2. DELEGATION OF AUTHORITY TO DEPARTMENTS HEADS. The Department Heads are delegated the authority to conduct shopping and small value procurement under 2016 RIRR of RA 9184 for items with ABC of Php 5,000 or below, and to award contracts for procurement with same ABC procured through Shopping under Section 52.1(a) of the 2016 RIRR of RA 9184.

**SECTION 3. POWER OF PROCUREMENT REVIEW AND RATIFICATION**. As required under Section J of Annex "H" of the 2016 RIRR of RA 9184, all awards shall be immediately reported with all supporting documents to the Head of the Procuring Entity, through the BAC, to ensure compliance with all the conditions and requirements provided under RA 9184, its RIRR, and related guidelines. Consistent with the same provision, the BAC retains its authority to review and ratify and if applicable, disapprove contracts that it deems not in compliance with RA 9184 and its 2016 RIRR.

This delegation of authority shall not be understood as toleration of splitting of contracts nor inadequate procurement planning, as mandated under RA 9184.

SECTION 4. LIMIT ON MEALS ACCOMMODATION. Relative to procurement of meals through Shopping under Section 52.1(a), the following limits are to be considered:

SECTION 5. SEPARABILITY CLAUSE. If any provision of the Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

SECTION 6. REPEALING CLAUSE. All other orders, rules, regulations and issuances, or parts thereof, which are inconsistent with this Order, are hereby repealed, amended or modified accordingly.

SECTION 7. EFFECTIVITY CLAUSE. This Executive Order shall take effect immediately and will continue until amended or revoked.

Let copies of this Order be furnished to offices and departments concerned.
