EXECUTIVE ORDER No. 50

Series of 2020

“AN ORDER PLACING THE AFFECTED AREA OF PUROK1 , BRGY. POBLACION SUR, BAYAMBANG, PANGASINAN IN A STATE OF LOCKDOWN”

WHEREAS, Article II, Section 15 of the Constitution declared it a policy of the State to protect and promote the right to health of the people;

WHEREAS, the COVID-19 pandemic is recognized by the State as a threat to public health and national security;

WHEREAS, Bayambang has experienced an alarming rise in the confirmed cases of COVID-19 in the municipality over the past weeks;

WHEREAS, Sec. 455(b)(1)(vii) of the Local Government Code allows the Municipal Mayor to carry out emergency measures as may be necessary during times of calamity;

WHEREAS, local government units are empowered to conduct rapid containment, quarantine and isolation, disease prevention and control measures under Section 4 (f) of Republic Act No. 1132;

NOW, THEREFORE, I, DR. CEZAR T. QUIAMBAO, by virtue of the powers vested in me as the Municipal Mayor of Bayambang, do hereby place Purok 1 of Barangay Poblacion Sur, Bayambang, Pangasinan in a state of lockdown starting on **September 17, 2020 (12AM)** until **October 1, 2020 (12AM)** unless shortened or extended for medical cause and further order of the following:

1. The barangay shall adopt the IATF Guidelines on Enhanced Community Quarantine (ECQ) wherein all residents are mandated to stay inside their homes with the exception to those who are considered as Authorized Persons Outside of Residence (APORs).
2. All entry and exit points of the barangay shall be strictly monitored by the Barangay Council with the help of the Philippine National Police - Bayambang and they shall impose fines to any person or group who unreasonably refuses to abide by or deliberately violates the guidelines on the grounds of Disobedience or Resistance to Agents of Persons in Authority.

3. The Chief of Police and the Punong Barangay of Barangay Poblacion Sur is hereby directed to enforce to the fullest extend the following:
 - a. The implementation of strict home quarantine among the residence of the affected area and the prohibition of social gathering among them.
 - b. The implementation of social distancing and wearing of facemask and face shield for those falling under the exceptions.
4. The Municipal Health Office is hereby ordered to conduct Reverse transcription-polymerase chain reaction (RT-PCR)/ swab testing for the close contact of the new active cases.

This Executive Order shall take effect immediately and shall remain in effect until the final day of the lockdown.


The Local Government Unit of Bayambang has effectively placed Purok 1 of Barangay Poblacion Sur, Bayambang, Pangasinan under Enhanced Community Quarantine (ECQ) **from September 17, 2020; 1AM until October 1, 2020; 12AM** by virtue of Executive Order No. 50. This purok was identified due to six (6) positive COVID-19 cases recorded in a single day and are now placed in our isolation facility, bringing the total number of active positive cases in the municipality to twenty (20). This alarming increase in the number of cases in the town has called for the immediate action of the LGU.

Pursuant to the Omnibus Guidelines on the Implementation of Localized Community Quarantine, the local chief executive immediately placed Purok 1 of Brgy. Poblacion Sur under ECQ in concurrence with the Regional IATF, to prevent further infection and to properly address the health concern in the local community.
