WHEREAS, the Province of Pangasinan, including the Municipality of Bayambang remains to be under Modified General Community Quarantine from October 1-31, 2020, upon the recommendations of the Inter-Agency Task Force for Management Infectious Diseases;

WHEREAS, under Section 444 (b) (1) (vii) of the Local Government Code of 1991, the Municipal Mayor is authorized to carry out such emergency measures as may be necessary during and in the aftermath of man-made and natural disasters and calamities;

WHEREAS, on September 17, 2020, upon the recommendations of the Bayambang CoViD-19 Inter-Agency Task Force, Executive Order No. 52, series of 2020 was issued mandating the Implementation of Quarantine Pass System in all establishments in the Municipality and requiring the Issuance of Travel Passes to ensure that quarantine protocol are strictly implemented;

WHEREAS, in light of the emergence of two (2) new confirmed CoViD-19 positive cases, the Bayambang CoViD-19 Inter-Agency Task Force recommended the extension of the effectivity of Executive Order No. 52, series of 2020;

NOW THEREFORE, I, **DR. CEZAR T. QUIAMBAO**, by virtue of the powers vested in me by law as the **Municipal Mayor of Bayambang, Pangasinan**, do hereby **ORDER THE EXTENSION OF THE EFFECTIVITY OF EXECUTIVE ORDER NO. 52** and **AMENDING SOME OF ITS PROVISIONS AND OTHER RELATED PURPOSES, TO WIT:**

SECTION 3. RELAXING SOME PROVISIONS OF EXECUTIVE ORDER NO. 45, SERIES OF 2020. The ban on selling of liquor, alcoholic drinks or beverages is hereby lifted provided that selling of liquor shall not be allowed during the curfew hours from 8PM to 5AM. However, drinking in public places is still strictly prohibited and commercial establishments are not allowed to serve alcoholic drinks or liquor within their premises.

SECTION 4. STATUTORY CONSTRUCTION. Any doubt on the interpretation of the Executive Order shall be construed liberally to the citizens and strictly on the enforcers.

SECTION 5. SEPARABILITY CLAUSE. If any provision of the Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

SECTION 6. REPEALING CLAUSE. All other orders, rules, regulations and issuances, or parts thereof, which are inconsistent with this Order, are hereby repealed, amended or modified accordingly.

SECTION 7. EFFECTIVITY CLAUSE. This Executive Order shall take effect immediately and shall remain in effect unless sooner revoked or amended.

Let copies of this Order be furnished to Offices and Departments concerned including but not limited to, the DILG and Inter Agency Task Force, the Philippine National Police and all Barangays for their information and guidance. Further, let copies of this Order be furnished to the neighboring Municipalities for their information and appropriate action.

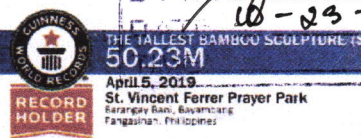
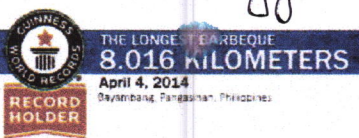

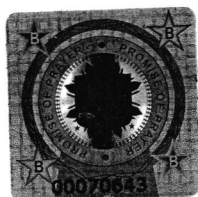

“AN ORDER DESIGNATING ENERGY EFFICIENCY AND CONSERVATION OFFICER (EECO) FOR THE MUNICIPALITY OF BAYAMBANG”

WHEREAS, per DILG RO Memorandum dated May 9, 2020 attaching therewith pertinent issuance-documents from the Department of Energy (DOE) pertaining to the implementation of required LGU actions and activities pursuant to RA No. 11285 or the Energy Efficiency and Conservation Act (EE&C Act);

WHEREAS, pursuant to RA No. 11285 envisioned to institutionalize energy efficiency and conservation as a national way of life geared towards building our country as it results to lower energy demand and increased energy security that would resound to improve productivity and energy savings for consumers;

WHEREAS, Section 45 of the Implementing Rules and Regulations (IEC-IRR) of the EE&C Act requires the designation of an Energy Efficiency and Conservation Officer (EECO) by each government entity to address the thrust of the Government Energy Management Program (GEMP);


NOW, THEREFORE, I, DR. CEZAR T. QUIAMBAO, Municipal Mayor of Bayambang, Pangasinan, by virtue of the powers vested in me by law, do hereby order to designate **ENGR. RUDYFER P. MACARANAS, Administrative Assistant V**, as the **Energy Efficiency and Conservation Officer (EECO)** for the Municipality of Bayambang.

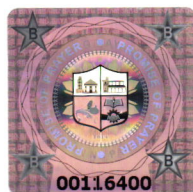
SECTION 1. DUTIES AND RESPONSIBILITIES

1. Prepare, formulate and submit for approval of the head of the government entity he design, plan and implementation, monitoring and evaluation scheme for the energy efficiency and conservation program consistent with the GEMP;
2. Submit to Department of Energy (DOE) the government entity's approved annual energy efficiency and conservation program; and
3. Submit to Department of Energy (DOE) the monthly energy performance report.

SECTION 2. EFFECTIVITY. This Executive Order shall take effect immediately.
