**DECLARING MUNICIPAL ORDINANCE NO. 09, S-2020 OF THE SANGGUNIANG BAYAN OF BAYAMBANG, PANGASINAN, ENTITLED "AN ORDINANCE GRANTING RELIEF IN THE FORM OF CONDONATION OF ONE (1) MONTH MARKET STALL RENTAL FEE AT THE PUBLIC MARKET FOR THE DURATION OF THE ENHANCED COMMUNITY QUARANTINE (ECQ)" AS WITHIN THE CONFERRED POWER OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Bayambang, Pangasinan submitted its Municipal Ordinance No. 09, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 192 of RA 7160 and Section 4 (2) of RA No. 11469, otherwise known as "Bayanihan To Heal As One Act":

**WHEREAS**, subject ordinance shall take effect after the requirement of posting pursuant to Section 59 (a) of RA 7160 is complied with;

**AN ORDINANCE GRANTING RELIEF IN THE FORM OF CONDONATION OF ONE (1) MONTH MARKET STALL RENTAL FEE AT THE PUBLIC MARKET FOR THE DURATION OF THE ENHANCED COMMUNITY QUARANTINE (ECQ)**

**EXPLANATORY NOTE**

**WHEREAS**, Presidential Proclamation No. 922, S-2020, was issued declaring a State of Public Health Emergency throughout the Philippines due to the Coronavirus Disease 2019 (COVID-19), Further, Presidential Proclamation No. 929, S-2020, was issued declaring a State of Calamity throughout the Philippines and imposed an Enhanced Community Quarantine throughout Luzon;

**WHEREAS**, the COVID-19 pandemic has greatly affected nations worldwide, including the Philippines, and has caused and is continuing to cause loss of lives and disruption to the economy;

**WHEREAS**, on March 16, 2020, an Enhanced Community Quarantine, which takes effect at midnight of March 17, 2020, has been announced strengthening the stringent social distancing measures including closure of business establishments other than those providing basic necessities and such activities related to food and medicine production;

**WHEREAS**, the Municipality of Bayambang recognizes the probable socio-economic outcome of the temporary closure of business during the quarantine period;

**WHEREAS**, the Municipality of Bayambang acknowledges the lack of income by the market stall holder covered by the temporary closure order during community quarantine, thus, hampering their capacity to pay the rental fee;

**NOW THEREFORE**, on motion of SB Member Joseph Vincent E. Ramos, duly seconded;

*BE IT ENACTED*, by the Sangguniang Bayan of Bayambang in session assembled that:

**SECTION 1. SCOPE AND APPLICATION.** This relief is applicable to all market stall holders (lessee) of the public markets within the Municipality of Bayambang.

**SECTION 2. RELIEF IN THE FORM OF CONDONATION.** A relief from market stall rental fees is hereby given in the form of CONDONATION on the unpaid market stall fees, interests, penalties and surcharges in the Municipality of Bayambang for a period of One (1) Month. Those who were able to pay the rental fee covering the period of March 1- March 31, 2020 will be applied to the subsequent month for equal imposition of the condonation made by LGU Bayambang.

**SECTION 3. PERIOD OF COVERAGE.** The relief in the form of condonation shall cover interests, penalties, and surcharges arising from unpaid or delayed payment of market rental fee for the period during the Enhanced Community Quarantine which took effect on March 17, 2020 and ends on April 13, 2020.

**SECTION 4. AUTHORIZATION OF THE MUNICIPAL TREASURER.** The Municipal Treasurer is hereby authorized to facilitate the implementation of this ordinance.

**SECTION 5. SEPARABILITY CLAUSE.** If for any reason, any section or provision of this ordinance is declared illegal or unconstitutional, other sections or provisions hereof which are not affected thereby shall continue to be in full force and effect.

**SECTION 6. REPEALING CLAUSE.** Any previously issued ordinance, or provision of this ordinance, which is inconsistent herewith is hereby repealed accordingly.

**SECTION 7. EFFECTIVITY CLAUSE.** This ordinance shall take effect upon its approval.
