EXECUTIVE ORDER No. 58 Series of 2020

AN ORDER IMPLEMENTING THE INTER AGENCY TASK FORCE RESOLUTION NO. 79 SERIES OF 2020 WITH MODIFICATION IN THE MUNICIPALITY OF BAYAMBANG, PANGASINAN AND OTHER RELATED MATTERS

WHEREAS, on September 16, 2020, the President issued Proclamation No. 1021 series of 2020 extending the period of the State of Calamity throughout the Philippines due to CoViD-19;

WHREAS, the Province of Pangasinan, including the Municipality of Bayambang remains to be under Modified General Community Quarantine from October 1-31, 2020, upon the recommendations of the Inter-Agency Task Force for Management Infectious Diseases;

WHEREAS, IATF Resolution No. 79 dated October 15, 2020 resolved and approved the lowering the age limit for minors who are restricted to stay at home provided that the local government units retain the authority to impose a higher age limit for minors depending on the CoViD-19 situation in the area of jurisdiction;

WHEREAS, under Section 444 (b) (1) (vii) of the Local Government Code of 1991, the Municipal Mayor is authorized to carry out such emergency measures as may be necessary during and in the aftermath of man-made and natural disasters and calamities;

WHEREAS, upon careful contemplation on the possible effects of the easing on the stay at home restrictions, there is a need to retain some restrictions on the age limit for minors;

WHEREAS, Memorandum Circular No. 2020-140 of the Department of Interior and Local Government promulgated the Guidelines on the Resumption of Cockpit Operations or Cockfighting in Areas under Modified General Community Quarantine (MGCQ);

NOW THEREFORE, I, **DR. CEZAR T. QUIAMBAO**, by virtue of the powers vested in me by law as the **Municipal Mayor of Bayambang, Pangasinan**, do hereby **ORDER THE IMPLEMENTATION OF THE IATF RESOLUTION NO. 79 SERIES OF 2020 IN THE MUNICIPALITY, TO WIT:**

SECTION 1. RAISING THE AGE LIMIT RESTRICTIONS FOR SENIOR CITIZENS. Following the rules and guidelines of **IATF Resolution No. 79, series of 2020**, all SENIOR CITIZENS aged over 60 years old but below 65 years old without immunodeficiency or comorbidities may be allowed to go out of their homes;

SECTION 2. LIMITING THE AGE LIMIT FOR MINORS. Notwithstanding the IATF Resolution allowing minors aged 15 years old to below 21 years old go out of their homes, those persons below 18 years old shall be required to remain in their residences at all times, except when indispensable under the circumstances for obtaining essential goods and services, or for school purposes as may be allowed or permitted under the **Distance Learning Enhancement Program of the Department of Education particularly in Barangays Tanolong and Inanlorenza**; *Provided that*, all activities and movements allowed under the IATF guidelines for places under Modified General Community Quarantine for the said persons shall be permitted.

SECTION 3. RESUMPTION OF OPERATION OF LICENSED COCKPITS AND THE CONDUCT OF COCKFIGHTING ACTIVITIES. Subject to the restrictions of law on prohibited dates to conduct cockfight operations, cockfighting activities may now resume in the Municipality of Bayambang only in authorized cockfight arenas by the Municipality and subject to the terms and conditions of the IATF and DILG.

SECTION 4. AGE REQUIREMENT TO GAIN ENTRY. No person below twenty-one (21) years old shall be allowed entry into any of the cockfighting venue.

SECTION 5. HEALTH PROTOCOLS FOR THE RESUMPTION OF OPERATION OF LICENSED CONCKPITS AND THE CONDUCT OF COCKFIGHTING ACTIVITIES. The following are the minimum health protocols to be complied with in all authorized licensed cockpits:

- a. **WEARING OF PROTECTIVE DEVICES and OTHER PRECAUTIONARY MEASURES.** The following Guidelines on the wearing of protective devices and precautionary measures shall be observed
 - i. Face masks must be worn at all times.
 - ii. Masks with vents should not be used
 - iii. Cloth masks, with additional filter such as tissue paper or similar materials, may be used as long as clean and washed daily. The filter should be changed daily or after every sneezing or coughing episode, and should be properly disposed of after use. Hands should be washed or disinfected before replacing the filters
 - iv. Frequent mask handling and manipulation should be avoided
 - v. No face mask, no entry must be observed
 - vi. Face shields shall cover the entire face completely covering the sides and length of the face
 - vii. Visor-type face shields shall not be allowed



- viii. Face shields and masks should be worn together at all times
- ix. No face shield, no entry should be observed
- x. Physical distancing based on existing or prevailing guidelines as to minimum distance shall be observed at all times. This must be practiced in combination with the wearing of masks and face shields
- xi. A MAXIMUM of THREE (3) persons are allowed INSIDE THE RING or RUWEDA, and FOUR (4) owners and one (1) handler for each owner immediately outside the ring
- xii. Temperature check shall be mandatory prior to entry
- xiii. Persons with fever, or with CoViD-19 symptoms shall not be allowed entry
- xiv. Frequent handwashing with soap and water or the application of alcohol-based disinfectants shall also be mandatory prior to entry
- xv. Regular sanitation of facility shall be conducted before and after every event

b. PROVISION OF DISINFECTION MATERIALS. Handwashing stations, soap, sanitizers and other disinfecting or washing materials shall be made available to employees and clients.

c. DISPLAY OF SIGNAGES FOR VISUAL CUES AND REMINDERS. The following signages to remind the practice of proper handwashing and other hygiene behaviors shall be mandatory:

- i. Before and after handling food or eating.
- ii. After using the bathroom
- iii. Before and after taking off their face mask and/or face shield
- iv. After touching frequently-touched surfaces and objects such as stair railings, door knobs, etc.; and
- v. Before and after touching their face
- vi. Discouraging sharing of personal items or utensils to prevent possible transmission.

d. PROVISION FOR ADEQUATE VENTILATION. The cockpit operator shall provide adequate ventilation for natural air flow exchange turning off air-conditioning units to reduce air recirculation

e. PROHIBITED ACTS ON BETTING. The following activities shall be prohibited in the cockpit arena:

- i. **Shouting of bets.** Cashless betting via e-wallet, mobile phones and tablets are encouraged.
- ii. **Live Streaming.** No live streaming devices shall be allowed inside the arena. In-person audience, online or remote betting and the live broadcasting/telecasting of cockfighting are also prohibited.



SECTION 6. IMPLEMENTATION. The Philippine National Police Bayambang Municipal Police Station, in coordination with the Public Order and Safety Office shall be the lead agency in the implementation of this Order. The Municipal Planning and Development Coordinator together with the Rural Health Unit Sanitary Inspectors and the Municipal Engineering Office shall inspect the Cockpit Arenas in the Municipality and recommend, if warranted, the resumption of Operation of Licensed Cockpits and Conduct of Cockfighting Activities.


SECTION 7. SEPARABILITY CLAUSE. If any provision of the Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

SECTION 8. REPEALING CLAUSE. All other orders, rules, regulations and issuances, or parts thereof, which are inconsistent with this Order, are hereby repealed, amended or modified accordingly.

SECTION 9. EFFECTIVITY CLAUSE. This Executive Order shall take effect immediately and shall remain in effect unless sooner revoked or amended.

Let copies of this Order be furnished to Offices and Departments concerned including but not limited to, the DILG and Inter Agency Task Force, the Philippine National Police and all Barangays for their information and guidance. Further, let copies of this Order be furnished to the neighboring Municipalities for their information and appropriate action.
