**RECOMPOSITION OF THE BIDS AND AWARDS COMMITTEE


The BAC shall be primarily responsible for the posting of advertisements and/or invitations to bid, preparation of pre-procurement and pre-bid conferences, determination of the eligibility of prospective bidders, recommend award of contract to the Local Chief Executive of the Municipality.

The BAC Secretariat shall be primarily responsible for the canvass and procurement of goods and services, preparation of resolutions and recommendation for the award of Contract for approval of the BAC and Head of Procuring Entity.

All proceedings of the BAC shall be done in accordance with the requirements set forth in **Republic Act No. 9184** and its Revised Implementing Rules and Regulations.

This Order shall be effective immediately.
