## **EXECUTIVE ORDER No. 06** Series of 2021

## AN ORDER REIMPOSING THE PROHIBITIONS IN **EXECUTIVE ORDER NO. 52, SERIES OF 2020, SUSPENDING COCKFIGHT OPERATIONS AND GUIDELINES UNDER EXECUTIVE ORDER NO. 58,** SERIES OF 2020 AND OTHER RELATED MEASURES

WHEREAS, the Province of Pangasinan, including the Municipality of Bayambang remains to be under Modified General Community Quarantine, upon the recommendations of the Inter-Agency Task Force for Management Infectious Diseases;

WHEREAS, under Section 444 (b) (1) (vii) of the Local Government Code of 1991, the Municipal Mayor is authorized to carry out such emergency measures as may be necessary during and in the aftermath of man-made and natural disasters and calamities;

WHEREAS, on January 27, 2021, the Bayambang CoViD-19 Inter-Agency Task Force, convened and made recommendations to ensure that quarantine protocols are strictly implemented;

WHEREAS, in light of the emergence of two (2) new confirmed CoViD-19 positive cases, the reimposition of stricter quarantine measures is warranted;

NOW THEREFORE, I, DR. CEZAR T. QUIAMBAO, by virtue of the powers vested in me by law as the Municipal Mayor of Bayambang, Pangasinan, do hereby ORDER THE REIMPOSITION OF PROHIBITIONS IN EXECUTIVE ORDER NO. 52 and SUSPENDING THE COCKFIGHT OPERATIONS AND GUIDELINES UNDER EXECUTIVE ORDER NO. 58, SERIES OF 2020 AND OTHER **RELATED MEASURES, TO WIT:**

SECTION 1. REIMPOSITION OF THE LIQUOR BAN UNDER EXECUTIVE ORDER NO. 52, SERIES OF 2020. The SELLING of liquor and alcoholic drinks as well as DRINKING IN PUBLIC PLACES is HEREBY PROHIBITED effective 12:01AM of January 29, 2021 until further notice.

SECTION 2. STRICTER IMPLEMENTATION OF MINIMUM HEALTH STANDARDS PROTOCOLS IN ALL ESTABLISHMENTS. Although Quarantine Passes previously issued for Authorized Persons Outside Residence, Heads of Households and Travel Passes to Non-APORs travelling within the municipality and outside the province shall NOT BE REQUIRED, all establishments are hereby ORDERED TO IMPLEMENT STRICTLY THE MINIMUM HEALTH STANDARDS PROTOCOLS such as, but not necessarily limited to physical distancing of at least one (1) meter, wearing of prescribed face shields and facemasks, handwashing and hand sanitizing;

SECTION 3. SUSPENDING THE PROVISIONS OF EXECUTIVE ORDER NO. 58, SERIES OF 2020. Section 3 of Executive Order No. 58, series of 2020 on resumption of cockpit operations is hereby suspended. <u>NO</u> <u>COCKFIGHTING ACTIVITIES</u> SHALL BE ALLOWED IN THE MUNICIPALITY EFFECTIVE 12:01AM OF JANUARY 29, 2021 UNTIL FURTHER NOTICE.

SECTION 4. REITERATION OF "NO PERMIT NO GATHERING", AGE LIMIT AND WAKE AND FUNERAL POLICIES. The following policies are hereby reiterated:

- a. Social gatherings of more than twenty (20) persons must secure a permit from the Rural Health Unit having jurisdiction on their Barangay. The venue must be properly ventilated and that the attendees must be limited to only up to fifty percent (50%) of the capacity of the venue.
- b. Only individuals at least fifteen years old but not more than sixty-five years old are allowed to go out of their residences provided that the purpose is to secure essentials goods or services.
- c. Wakes of departed persons shall only be allowed up to five (5) days with only immediate family members allowed to stay at the venue. Relatives and friends from outside the barangay or from outside the Municipality are being encouraged to refrain from attending the wake. Immediate family members from outside the Province are required to present their Travel Authority and Medical Clearance to the Punong Barangay or any barangay official upon arrival in the place of the wake. Funeral processions are encouraged to be through the use of vehicles with observance of minimum health standards. *Provided*, that, no wake or funeral procession shall be allowed on suspected individuals who died of or with CoViD-19.

**SECTION 5. SEPARABILITY CLAUSE.** If any provision of the Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

**SECTION 6. REPEALING CLAUSE.** All other orders, rules, regulations and issuances, or parts thereof, which are inconsistent with this Order, are hereby repealed, amended or modified accordingly.

## SECTION 7. EFFECTIVITY CLAUSE. This Executive Order shall take effect immediately and shall remain in effect unless sooner revoked or amended.

Let copies of this Order be furnished to Offices and Departments concerned including but not limited to, the DILG and Inter Agency Task Force, the Philippine National Police and all Barangays for their information and guidance. Further, let copies of this Order be furnished to the neighboring Municipalities, and the Provincial Government for their information and appropriate action.
