#### **“RECONSTITUTION OF LOCAL PUBLIC TRANSPORT ROUTE PLANNING TEAM FOR THE PREPARATION OF THE LOCAL PUBLIC TRANSPORT ROUTE PLAN IN THE MUNICIPALITY OF BAYAMBANG, PANGASIANAN”**

**WHEREAS**, the Department of Transportation (DOTr) has entered into an agreement with the Department of Interior and Local Government (DILG), through Joint Memorandum Circular No. 1 dated June 19, 2017, specifically, as regards to local government units' preparation, submission and adoption of Local Public Transport Route Plan (LPTRP), which will be the basis for the Land Transportation Franchising and Regulatory Board's (LTFRB) issuance of franchises to public utility vehicles;

**WHEREAS**, the LPTRP is minimum requirement prescribed for the issuance of Public Utility Vehicle (PUV) Franchises. This shall form part of the Local Transport Master Plan (LTMP) which relates land use to transport modes and provides measures for traffic management;

**WHEREAS**, DILG Memorandum Circular No. 2018-60 dated May 03, 2018 mandated all Local Chief Executive to mobilize a LPTRP Team composed of competent personnel from the planning and development, engineering and traffic management, who shall be responsible for the preparation of the LPTRP;

**NOW, THEREFORE, I. DR. CEZAR T. QUIAMBAO**, Municipal Mayor of Bayambang, Pangasinan, by virtue of powers vested in me by law, do hereby reconstitute and mobilize the Local Public Transport Route Plan (LPTRP) Team to prepare the Local Public Transport Route Plan (LPTRP).

**SECTION 1. COMPOSITION.** The Local Public Transport Route Plan (LPTRP) Team is hereby reconstituted with the following members:

**SECTION 2. FUNCTIONS.** The LPTRP shall perform the following:

1. Make preparations for the formulation of the LPTRP for infra-municipality trips.
2. Participate in trainings and other capacity building activities to be conducted by the DOTr, to be facilitated by the LTFRB and in coordination with the DILG Regional Office.
3. Make consultations with the concerned stakeholders with the municipality particularly the commuters, transport groups, the academe, among others, incorporating their valuable inputs and comments.

4. Submit the LPTRP to the Local Chief Executive for review of all issued ordinances, orders, rules and regulations concerning local public transport routes.


**SECTION 6. SEPARABILITY CLAUSE.** If any provision of the Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

**SECTION 7. REPEALING CLAUSE.** All other orders, rules, regulations and issuances, or parts thereof, which are inconsistent with this Order, are hereby repealed, amended or modified accordingly.

**SECTION 8. EFFECTIVITY CLAUSE.** This executive order shall take effect immediately and will continue until amended or revoked.

Let copies of this Order be furnished to Offices and Departments concerned, the MLGOO and all Barangays for their information and guidance.
