WHEREAS, the Bids and Awards Committee received request from the Head of the Procuring Entity through the Office of the Municipal Administrator for the **SUPPLY DELIVERY OF CONSTRUCTION MATERIALS FOR MULTI-PURPOSE COVERED COURT**;

WHEREAS, on the basis of the said request the Bids and Awards Committee caused the publication of the advertisement for the Invitation to Bid in Phil-GEPS website (www.philgeps.gov.ph) on **FEBRUARY 26, 2021**, which was created on **FEBRUARY 24, 2021**, continuously for seven (7) calendar days;

WHEREAS, in response to the said advertisement, *two bidders* expressed their interest in participating in the procurement process of the **SUPPLY DELIVERY OF CONSTRUCTION MATERIALS FOR MULTI-PURPOSE COVERED COURT**;

WHEREAS, on **March 17, 2021** the Opening of Bids was conducted at the Bayambang Events Center, Bayambang, Pangasinan and upon careful examination and checking of bid validity, the Bids and Awards Committee declared **GEORAVIN CONSTRUCTION & SUPPLIES "COMPLYING"**;

WHEREAS, **GEORAVIN CONSTRUCTION & SUPPLIES** bid As Read was **FOUR MILLION SIXTEEN THOUSAND EIGHT HUNDRED FORTY PESOS (PHP 4,016,840.00) ONLY**;


WHEREAS, after careful evaluation and post-qualification by the Technical Working Group (TWG), **GEORAVIN CONSTRUCTION & SUPPLIES** of Poblacion, Labrador, Pangasinan was declared "RESPONSIVE";



WHEREAS, in response to the said advertisements, two (2) prospective bidders submitted bid proposals thereof;

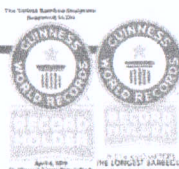
WHEREAS, opening of the bid proposals of the two (2) prospective bidders resulted as follows:


