#### **“AN ORDER CREATING THE BAYAMBANG VIOLENCE AGAINST WOMEN (VAW) DESK INTER-AGENCY MONITORING TEAM (BVAWDIMT)”**

**WHEREAS**, the **Magna Carta of Women (MCW)** is a comprehensive women’s human rights law that seeks to eliminate discrimination through the recognition, protection, fulfillment, and promotion of the rights of Filipino women, especially those belonging in the marginalized sectors of the society. It conveys a framework of rights for women based directly on international law.

**WHEREAS**, the Department of Interior and Local Government released Memorandum Circular No. 2017-114, Guidelines in Monitoring the Functionality of Violence Against Women (VAW) Desk in every Barangay, states that an Inter-Agency Monitoring Team (IMT) shall be created at the city/municipal level to monitor the establishment and evaluate the functionality of VAW Desk in every barangay;

**WHEREAS**, to fully operationalize this program and ensure the functionality of every VAW Desks in every barangay, there is a need to establish a monitoring team at the municipal.

**NOW, THEREFORE, I, DR. CEZAR T. QUIAMBAO**, Municipal Mayor of Bayambang, Pangasinan, by virtue of the powers vested in me by law, do hereby order the **Creation of Bayambang Violence Against Women Desk Inter-Agency Monitoring Team (BVAWDIMT)** in the Municipality of Bayambang, Pangasinan:

**SECTION 1. CREATION.** The **Bayambang Violence Against Women Desk Inter-Agency Monitoring Team** is hereby created with the following composition:

**SECTION 2. DUTIES AND RESPONSIBILITIES.** The IMT shall perform the following duties and responsibilities:

1. Evaluate the Barangay VAW Desk based on the documents submitted using VAW Desk Form 1;
2. Conduct site inspections and meet the concerned barangay officials for feedbacking on the strengths or weaknesses of the VAW Desk;
3. Discuss with the concerned mayors on the outcome of the evaluation;
4. Come up with the recommended actions; and
5. Using VAW Desk Form 2, submit report in soft and hard copies to the DILG Provincial Office not later than April 15 of every year.


**SECTION 3. SEPARABILITY CLAUSE.** If any provision of the Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

**SECTION 4. REPEALING CLAUSE.** All other orders, rules, regulations and issuances, or parts thereof, which are inconsistent with this Order, are hereby repealed, amended or modified accordingly.

**SECTION 5. EFFECTIVITY CLAUSE.** This executive order shall take effect immediately and will continue until amended or revoked.

Let copies of this Order be furnished to Offices and Departments concerned, the MLGOO and all Barangays for their information, guidance and appropriate action.
