# "AN ORDER CREATING THE TECHNICAL WORKING GROUP (TWG) ON POLLUTION CONTROL IN THE MUNICIPALITY OF BAYAMBANG, PANGASINAN"

WHEREAS, Republic Act No. 9003, an Act Providing for an Ecological Solid Waste Management Program, creating the necessary institutional mechanisms and incentives, declaring certain acts prohibited and providing penalties, appropriating funds therefor, and for other purposes or shall be known as the "Ecological Solid Waste Management Act of 2000";

**WHEREAS,** Republic Act No. 6969, an Act to Control Toxic Substances and Hazardous and Nuclear Wastes, Providing Penalties for Violations Thereof, and for Other Purposes or shall be known as the "Toxic Substances and Hazardous and Nuclear Wastes Control Act of 1990";

**WHEREAS,** Republic Act No. 8749, an Act Providing for a Comprehensive Air Pollution Control Policy and for Other Purposes or shall be known as the "Philippine Clean Air Act of 1999";

WHEREAS, Republic Act No. 9275, an Act Providing for a Comprehensive Water Quality Management and for Other Purposes or shall be known as the "Philippine Clean Water Act of 2004";

WHEREAS, Presidential Decree No. 1586, Establishing an Environmental Statement System Including Other Environmental Management Related Measures and for Other Purposes;

WHEREAS, to fully operationalize this program, there is a need to organize a Technical Working Group on Pollution Control in the Municipality of Bayambang, Pangasinan;

NOW, THEREFORE, I, DR. CEZAR T. QUIAMBAO, Municipal Mayor of Bayambang, Pangasinan, by virtue of the powers vested in me by law, do hereby order the Creation of the Technical Working Group on Pollution Control in the Municipality of Bayambang, Pangasinan:

**SECTION 1. CREATION.** The **Technical Working Group on Pollution Control** is hereby created with the following composition:

# **SECTION 2. DUTIES AND RESPONSIBILITES.** The TWG shall perform the following duties and responsibilities:

- 1. To determine and enumerate the LGU's Commitment to Department of Environment and Natural Resources (DENR) from their technical inspection.
- 2. To Ensure the proper performance, operation and maintenance of environmental management facilities or systems of the establishment such as the following:
  - Wastewater treatment facilities
  - Air pollution control devices referred to in DAO 2000-03;
  - Hazardous waste management storage areas (permanent or temporary);
  - Solid waste segregation/management facilities (i.e. MRF's, Sanitary Landfills, Composting Facilities, etc); and
  - Environmental monitoring devices such as the Continuous Emission Monitoring Systems, Air Monitoring Stations, effluent flow metering/measuring devices, groundwater-monitoring wells, and other environmental monitoring devices.

- 3. Ensure that the hazardous waste disposed offsite are covered by a Permit to Transport; each transport is covered by hazardous waste manifest duly signed by the transporter and TSD facility; and with corresponding Certificate of Treatment (COT) duly signed by the TSD Facility, Copies of the signed hazardous waste manifest and (COT) shall be submitted to the concerned EMB Regional Office in accordance with DENR Adm. Or No. 2004-36;
- 4. To update online the requirement and checklist for environmental compliance of concern facilities.
- 5. To Design and Detailed Estimate as one of the main requirements. (For submission of Engineer's Report(ER), Self-Monitoring Report (SMR), Compliance Monitoring report (CMR).
- 6. To conduct joint ocular inspection of various location and facilities concerning the environmental compliance of DENR.
- 7. Initiate and Intensify environmental management activities including awareness campaign within the Municipality.
- 8. Participate in multi-party monitoring team activities and meetings.

**SECTION 3. SEPARABILITY CLAUSE.** If any provision of the Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

**SECTION 4. REPEALING CLAUSE.** All other orders, rules, regulations and issuances, or parts thereof, which are inconsistent with this Order, are hereby repealed, amended or modified accordingly.

**SECTION 5. EFFECTIVITY CLAUSE.** This executive order shall take effect immediately and will continue until amended or revoked.

Let copies of this Order be furnished to Offices and Departments concerned, for their information, guidance and appropriate action.
