EXECUTIVE ORDER No. 09

AN ORDER LIFTING THE LIQUOR BAN AND THE SUSPENSION OF COCKFIGHT OPERATIONS AND OTHER RELATED MEASURES

WHEREAS, the Province of Pangasinan, including the Municipality of Bayambang remains to be under Modified General Community Quarantine, upon the recommendations of the Inter-Agency Task Force for Management Infectious Diseases;

WHEREAS, under Section 444 (b) (1) (vii) of the Local Government Code of 1991, the Municipal Mayor is authorized to carry out such emergency measures as may be necessary during and in the aftermath of man-made and natural disasters and calamities;

WHEREAS, on February 15, 2021, the Bayambang CoViD-19 Inter-Agency Task Force, convened and made recommendations to make adjustments to the quarantine protocols;

NOW THEREFORE, I, **DR. CEZAR T. QUIAMBAO**, by virtue of the powers vested in me by law as the **Municipal Mayor of Bayambang, Pangasinan**, do hereby **ORDER THE REIMPOSITION OF PROHIBITIONS IN EXECUTIVE ORDER NO. 52 and SUSPENDING THE COCKFIGHT OPERATIONS AND GUIDELINES UNDER EXECUTIVE ORDER NO. 58, SERIES OF 2020 AND OTHER RELATED MEASURES, TO WIT:**

SECTION 1. LIFTING THE LIQUOR BAN UNDER EXECUTIVE ORDER NO. 52, SERIES OF 2020 AS REIMPOSED IN E.O. NO. 6 SERIES OF 2021. The PROHIBITION ON THE SELLING of liquor and alcoholic drinks IS HEREBY LIFTED but DRINKING IN PUBLIC PLACES is **STILL PROHIBITED** effective **immediately**.

SECTION 2. LIMITING THE DRINKING OF LIQUOR AMONG FAMILY MEMBERS OR MEMBERS OF THE SAME HOUSEHOLD. It is hereby encouraged that the intake of liquor and celebrations with drinking sessions shall be limited among family members or members of the household within the same house.

SECTION 3. ALLOWING THE RESUMPTION OF COCKPIT OPERATIONS. DULY LICENSED COCKPIT ARENAS SHALL NOW BE ALLOWED TO OPERATE IN THE MUNICIPALITY EFFECTIVE 12:01AM OF FEBRUARY 19, 2021, provided, that ALL PUBLIC HEALTH PROTOCOLS must be STRICTLY OBSERVED AND NEITHER SELLING NOR DRINKING OF LIQUOR SHALL BE ALLOWED IN THE COCKPIT ARENA. Any violation shall result to the suspension of the permit of the cockpit arena as may be warranted.

SECTION 4. DESIGNATION OF ALLOWED PARKING AREAS WITHIN THE CENTRAL BUSINESS DISTRICT. In order to accommodate the employees and clients doing business at the Municipal Annex Building, the Municipal Police Station and the Rural Health Unit I, the shoulder of the Municipal Road along **MAGSAYSAY STREET is hereby designated as an additional ALLOWED PARKING AREA** to be supervised by the Public Order and Safety Office, effectively immediately.

SECTION 5. TEMPORARY CLOSURE AND DISINFECTION OF THE BAGSAKAN AREA. Effective February 19, 2021, the Bagsakan Area in the Bayambang Tricycle Terminal shall be closed to the public from **6PM to 7PM EVERYDAY** to give way for the disinfection operations to be headed by the Bureau of Fire Protection in coordination with and with the assistance of the Market Supervisor, POSO, PNP and MDRRMO.


SECTION 6. SEPARABILITY CLAUSE. If any provision of the Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

SECTION 7. REPEALING CLAUSE. All other orders, rules, regulations and issuances, or parts thereof, which are inconsistent with this Order, are hereby repealed, amended or modified accordingly.

SECTION 8. EFFECTIVITY CLAUSE. This Executive Order shall take effect immediately and shall remain in effect unless sooner revoked or amended.

Let copies of this Order be furnished to Offices and Departments concerned including but not limited to, the DILG and Inter Agency Task Force, the Philippine National Police and all Barangays for their information and guidance. Further, let copies of this Order be furnished to the neighboring Municipalities, and the Provincial Government for their information and appropriate action.
