## EXECUTIVE ORDER NO. 29 Series of 2021

## CREATION AND COMPOSITION OF TASK FORCE FOR INSPECTION OF

## SATELLITE MARKETS FOR THE EMPOWERMENT OF THE OPERATION OF SLAUGHTER HOUSE AND FOR SUCH RELATED PURPOSES

WHEREAS, Public Office is a Public Trust. It is a settled principle of law that Local Government Units are agencies of the State for the promotion and maintenance of local self-government and as such are endowed with the police powers in order to effectively accomplish and carry out the declared objects of its creation;

WHEREAS, Republic Act No. 7394, otherwise known as the Consumers Act of the Philippines, provides that the Department of Agriculture shall inspect and analyze consumer products related to agriculture to determine conformity to established quality and safety standards; and to levy, assess, collect, and retain fees as are necessary to cover the cost of inspection, certification, analysis, and test of samples of consumer products;

**WHEREAS**, the National Meat Inspection Commission (NMIC) of the Department of Agriculture, created under Presidential Decree No. 7 and Letter of Instruction No. 16, is responsible for promulgating specific policies and procedures governing the flow of livestock and livestock products through various stages of marketing and the proper preservation and inspection of such products;

WHEREAS, there is a need to harmonize the various provisions of the Local Government Code of 1991 and the Consumers Act of the Philippines, including the role of the National Meat Inspection Commission in the establishment, operation, and regulation of slaughterhouses, livestock, and meat inspection, and the imposition and collection of fees and other charges rendered thereon;

**WHEREAS**, Municipality of Bayambang is a booming town and its growing population demands an increase in supply of meat products aside from the negative effect of the African Swine Fever Calamity;

**WHEREAS**, there is a gradual increase of satellite markets around areas near our public market that are tax free and also sells meat and frozen products which are not slaughtered from the municipal abattoir and not inspected by the municipal veterinarian;

**WHEREAS**, there is an evident proof of contamination of meat and other meat products being sold at satellite markets due to its exposure from dust and other contaminants along the roads;

WHEREAS, to ensure effective and efficient management, administration, maintenance and sanitation, garbage free and viable operation of the municipal abattoir and satellite markets, and for the protection of legitimate meat vendors of our public market;

**WHEREAS**, there is a need of prohibition to sell meat and other frozen products in satellite markets to avoid the spread of any other disease cause by its contamination;

OFFICE OF THE MAYOR Municipal Hall, Roxas St Zone II, Bayambang, 2423 Pangasinan (075) 633-1000 Loc 100 WHEREAS, there is a need to create a Team to be known as "Satellite Market Monitoring and Inspection Team" to be vested with powers and authority to receive complaints, conduct fact-finding investigations regarding the rampant or discreet slaughtering of animals in any place other than the municipal slaughterhouse, and to submit its findings, reports and recommendation for closure of satellite market violators to the Municipal Veterinarian for his consideration;

**NOW, THEREFORE, I, CEZAR T. QUIAMBAO**, Municipal Mayor of the Municipality of Bayambang, Province of Pangasinan, by virtue of the powers vested in me by law, do hereby create the of the Municipality of Bayambang, with the following:

**SECTION 1. Creating the Satellite Market Monitoring and Inspection Team and providing for its composition.** A Team in the Municipal Government of Bayambang to be known as **"Satellite Market Monitoring and Inspection Team"** is hereby created to be composed of the Team Leader, Assistant Team Leader and other members.

The following are hereby designated as members of the S.M.M.I. Team:

SECTION 2. POWERS AND FUNCTIONS. The S.M.M.I. Team shall exercise powers and authority to:

- a. Receive complaints involving discreet slaughtering of animals in any other places than the Municipal Abattoir;
- b. Conduct investigations regarding the selling of meat and other frozen products in any Satellite Markets;
- c. Give recommendations for the closure of any violators;
- d. Submit its findings and recommendations to the Municipal Veterinarian;
- e. Exercise such other inherent, implied and incidental powers and functions as may be necessary to give effect to its main powers and authority.

**SECTION 3. SECRETARIAT.** A Secretariat is hereby created to assist the Team in the exercise of its functions like the recording of its operations, transcribing the records of the operations, preparation and furnishing of closure order for any violator, and other process to the concerned parties, and performing such other incidental and inherent administrative functions.

**SECTION 4. COMPENSATION AND REMUNERATION.** The team leader and members of the Team as well as its Secretariat shall perform their duties as such without any additional compensation or remuneration. However, the Municipal Budget Officer is hereby directed to allocate funds for their trainings and seminars to make the adopt to their designated functions.

**SECTION 5. SEPARABILITY CLAUSE.** If any provision of the Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

**SECTION 6. REPEALING CLAUSE**. All other orders, rules, regulation and issuances, or parts thereof, which are inconsistent with this Order, are hereby repealed, amended or modified accordingly.

**SECTION 7. EFECTIVITY CLAUSE**. This executive Order shall take effect immediately and will continue until amended or revoked.

Let copies of this Order be furnished to the Offices and Departments concerned, the Department of Agriculture and all Barangays for their information and guidance.
