#### “AN ORDER CREATING THE MUNICIPAL TECHNICAL COMMITTEE FOR ORGANIC AGRICULTURE”

**WHEREAS**, it is the duty of the local government to protect life and advance the rights of all citizens to food sufficiency, sovereignty and safety, sustainable livelihood and social equity in accord with the rhythm and harmony of nature;

**WHEREAS**, there is a need to mainstream organic agriculture as the central agriculture practice in the Municipality;

**WHEREAS**, in order to mainstream organic agriculture in the Municipality, there is a need to create a Municipal Technical Committee for Organic Agriculture;

**NOW, THEREFORE, I, DR. CEZAR T. QUIAMBAO**, by virtue of the powers vested in me by law as Municipal Mayor of Bayambang, do hereby order the creation of the Municipal Technical Committee for Organic Agriculture in the Municipality of Bayambang, Pangasinan.

**SECTION 2. DUTIES AD RESPONSIBILITIES.** The Municipal Technical Committee for Organic Agriculture shall perform the following:

- 1.) Formulate policies, plans, programs, and projects to develop and promote organic agriculture, production, processing and trade;
- 2.) Oversee the successful implementation of the National Organic Agricultural Program;
- 3.) Identify sources of financing to expand organic agriculture;
- 4.) Monitor and evaluate the performance of programs for appropriate incentives;
- 5.) Establish a strategic venue for education, information and communication for a sustainable healthy lifestyle;
- 6.) Design as a showcase for organic products and farm technologies;
- 7.) Develop holistic and sustainable technology training programs;
- 8.) Formulate farm-based farmer coordinated applied research program; and
- 9.) Promote environmental economic values in enterprise development;

**SECTION 3. SEPARABILITY CLAUSE.** If any provision of the Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

**SECTION 4. REPEALING CLAUSE.** All other orders, rules, regulations and issuances, or parts thereof, which are inconsistent with this Order, are hereby repealed, amended or modified accordingly.

**SECTION 5. EFFECTIVITY CLAUSE.** This Executive Order shall take effect immediately and will continue until amended or revoked.

Let copies of this Order be furnished to concerned departments/offices, agencies, barangays, MLGOO and the Office of the Governor for their information and guidance.
