AN EXECUTIVE ORDER CREATING BARANGAY PEACE AND ORDER COUNCIL (BPOC) EVALUATION TASK FORCE

WHEREAS, Section 5, Article II of the 1987 Constitution provides the maintenance of peace and order, the protection of life, liberty, and property, and promotion of general welfare are essential for the enjoyment by all the people of the blessings of democracy;

WHEREAS, Section 16 of Republic Act No. 7160 or the Local Government Code of 1991 states that the LGUs shall, within their territorial jurisdictions, promote health and safety, improve public morals, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, DILG MC No. 2008-101 entitled "Reorganization and Guidelines in the monitoring the Functionality of Barangay Peace and Order Committee (BPOC)" was formulated in order to ensure that the BPOCs are organized and functional;

WHEREAS, with the serious threat to peace and order and public safety in the country, DILG issued Memorandum Circular No. 2020-147 entitled "An Update on the Functionality Indicators, Rules and Responsibilities and Monitoring Guidelines of Barangay Peace and Order Committee (BPOC) Thereby amending DILG MC 2008-101 dated June 17, 2008;

NOW, THEREFORE, I, CEZAR T. QUIAMBAO, by virtue of the powers vested in me by law as Municipal Mayor of Bayambang, do hereby order the creation of an Executive Order Creating Barangay Peace and Order Council (BPOC) Evaluation Task Force:

SECTION 1. COMPOSITION. The BPOC Evaluation TASK Force shall be composed of the following:

SECTION 2. ROLES AND RESPONSIBILITIES. The BPOC Evaluation Task Force deliver the following functions:

- 1.) Consolidate the barangay self-assessment from (BPOC Form 1);
- 2.) Review and evaluate the data entries in BPOC Form 1, all Means of Verification (MOVs) and relevant documents for the assessment of the POC Functionality;
The ETF shall ensure that the barangays completely accomplished the BPOC Form 1 and submitted all their MOVs. In case that there are indicators without MOVs, it is considered none compliance, hence the 0-point score;
- 3.) Give corresponding points for each indicator guided by the BPOC Functionality Assessment Technical Guide notes and total all the points given for each indicator and indicate its level of BPOC Functionality in accordance with item 5.4 of the DILG MC 2020-147;
- 4.) Conduct Validation activities whenever necessary;
- 5.) Create ETF Secretariat, if deemed necessary, to assist the BPOC Evaluation Task Force in the performance of its administrative and technical functions; and
- 6.) Submit a copy of the BPOC Form to the MLGOO.

SECTION 3. SCHEDULE OF THE BPOC FUNCTIONALITY MONITORING AND REPORT SUBMISSION. The BPOC Functionality assessment shall be conducted annually in accordance with the following schedules:

For CY 2021- onwards:

Year under Review	Assessment Period	Submission of Assessment Report
2020	January to March 2021	On or before April 30, 2021
2021 onwards	January to March 2022 and every year thereafter	On or before April 30, 2022 and every year thereafter

SECTION 4. SEPARABILITY CLAUSE. If, for any reason, any part or provision of this Order shall be found unconstitutional or invalid, other parts or provisions thereof which are not affected thereby, shall continue to be in full force and effect.

SECTION 5. REPEALING CLAUSE. All other inconsistent issuances are hereby superseded.

SECTION 6. EFFECTIVITY CLAUSE. This Executive Order shall take effect immediately and will continue until amended or revoked.
