**“AN ORDER ESTABLISHING A CIVIL SOCIETY ORGANIZATION DESK IN
THE MUNICIPALITY OF BAYAMBANG, PANGASINAN”**

WHEREAS, Article II, Section 23 states that “The State shall encourage non-governmental, community-based or sectoral organizations that promote the welfare of the nation”;

WHEREAS, Article XIII, Section 15 states that “The State shall respect the role of independent people’s organizations to enable the people to pursue and protect, within the democratic framework, their legitimate and collective interests and aspirations through peaceful and lawful means”;

WHEREAS, Article XIII, Section 16 states that “The right of the people and their organizations to effective and reasonable participation at all levels of social, political and economic decision-making shall not be abridged. The state shall, by law, facilitate the establishment of adequate consultation mechanisms”;

WHEREAS, Section 34 of the Republic Act 7160 on the Local Government Code of 1991, states that “Local Government Units shall promote the establishment and operation of people’s and non-governmental organizations to become active partners in the pursuit of local autonomy”;

WHEREAS, Section 35 of the Republic Act 7160 on the Local Government Code of 1991, states that “Local Government Units may enter into joint ventures and such other cooperative arrangements with people’s and non-governmental organizations to engage in the delivery of certain basic services, capability building and livelihood projects, and to develop local enterprises designed to improve productivity and income, diversify agriculture, spur rural industrialization, promote ecological balance, and enhance the economic and social well-being of the people”;

WHEREAS, Section 36 of the Republic Act 7160 on the Local Government Code of 1991, states that “A Local Government Unit may, through its local chief executive and with the concurrence of the Sanggunian concerned, provide assistance, financial or otherwise, to such people’s and non-governmental organizations for economic, socially-oriented, environmental, and cultural projects to be implemented within its territorial jurisdiction”;

WHEREAS, to fully operationalize this program and ensure the functionality of Civil Society Organization Desk, there is a need to establish a monitoring team at the municipal level.

NOW, THEREFORE, I, DR. CEZAR T. QUIAMBAO, Municipal Mayor of Municipality of Bayambang, Pangasinan, by the virtue of the power vested in me by the law, do hereby order the Establishment of a Civil Society Organization Desk in the Municipality.

SECTION 1. ESTABLISHMENT OF CIVIL SOCIETY ORGANIZATION DESK.

There shall be Civil Society Organization Desk in the Municipality of Bayambang.

SECTION 2. DESIGNATION OF CIVIL SOCIETY ORGANIZATION DESK. The following personnel shall be designated as Staff of the CSO Desk in the Municipality of Bayambang:

SECTION 3. ROLES AND RESPONSIBILITES. The CSO Desk shall perform the following:

1. Cause the organization of federation or coalition of sectoral CSOs from the barangay level to municipal level; and municipal level to provincial level, including the formation of Peoples Council in the LGU;
2. Mobilize and ensure participation of accredited and recognized CSOs in the various processes and activities of the local government, particularly in planning, budgeting, monitoring and other service delivery areas;

3. Coordinate with the established Federation of Local CSO and People's Council, the holding of regular meetings, and other relevant activities of the CSOs;
4. Monitor, through the People's Council, CSO participation in the programs, projects and activities of the local governments;
5. Maintain and update local CSO database;
6. Collaborate and submit reports to the concerned DILG field officers on the matters relating to the programs, projects and activities of the CSOs; and
7. Perform relevant functions as may be required by higher authorities.

SECTION 4. SEPARABILITY CLAUSE. If any provision of the Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

SECTION 5. REPEALING CLAUSE. All other orders, rules, regulations and issuances, or parts thereof, which are inconsistent with this Order, are hereby repealed, amended or modified accordingly.

SECTION 6. EFFECTIVITY CLAUSE. This executive order shall take effect immediately and will continue until amended or revoked.

Let copies of this Order be furnished to Offices and Departments concerned, the MLGOO and the Office of the Sangguniang Panlalawigan and Provincial Governor for their information and guidance.
