AMENDMENT TO EXECUTIVE ORDER NO. 26 SERIES OF 2018 REGARDING THE REORGANIZING AND RECONSTITUTING THE MUNICIPAL MUSEUM AND LIBRARY COUNCIL OF THE MUNICIPALITY OF BAYAMBANG

WHEREAS, the Local Government of Bayambang desires to showcase the historical and cultural heritage of the Municipality of Bayambang through a museum to be called Balon Bayambang Museum;

WHEREAS, there is also a need to upgrade, through digitalization among other means, the Municipal Library of the Local Government Unit;

WHEREAS, such measures and improvements as mentioned above shall be of cultural, historical and economic benefits to the people of Bayambang as well as to the local government;

NOW THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO,

Municipal Mayor of the Municipality of Bayambang, Province of Pangasinan, by virtue of the powers vested in me by law, do hereby approve and order the reorganization and reconstitution of the Municipal Museum and Library Council of the Municipality of Bayambang, Pangasinan with members representing both the private and government sectors of this municipality under the following guidelines:

Section 2. Functions

General

- 2.1 To oversee the preparation of a Master Development Plan towards preservation of historical/cultural heritage of Bayambang.
- 2.2. To collect artifacts, identity and preserve the cultural heritage of Bayambang.
- 2.2.1 Collection of artifacts showcasing the early demographic ang psychographic of the people and local government of Bayambang.

- 2.2.2 Collection and labeling of old photos that are of local significance and importance.
- 2.2.3 Conduct of research activities with the National Museum, National Library and other similar museums, libraries and sources that could help meet the objectives set forth in this paper;
- 2.3 To collate all historical and cultural accounts significant to Bayambang.
- 2.4 To conduct research activities at the National Museum, National Library and other similar museum, libraries and sources that could help meet the stated objective.

Section 3. Meetings

The Municipal Museum & Library Council shall meet every first Tuesday of the month or as often as necessary), to tackle concerns and issues related to the tasks and objectives set forth in the early portion of this paper. The Sub-Committees shall meet at least once every two weeks or as often as necessary.

Section 4. Secretary to the Council

The secretary to the council shall provide assistance and record the minutes of the meeting.

Mr. David Christian A. Iglesias of the Museum Unit shall head the secretariat of the Council. He shall be assisted by all members in the performance of duties and functions.

Section 5. Effectivity

This Executive Order shall take effect immediately.

All orders, rules and regulations, issuances or any part of coming from this office that inconsistent with this order are hereby repealed, amended or modified accordingly.
