EXECUTIVE ORDER NO. 39 *series of 2022*

AN ORDER RENAMING THE PUBLIC ORDER AND SAFETY OFFICE (POSO) TO THE BAYAMBANG PUBLIC SAFETY OFFICE (BPSO)

WHEREAS, the National Economic Development Authority states that security and public order are essential in foundation-building for inclusive growth, economic development, and a resilient community;

WHEREAS, peace, justice, and strong institutions are part of the Sustainable Development Goals set by the United Nations in its 2030 Agenda for Sustainable Development;

WHEREAS, Section 16 of R.A. 7160, otherwise known as the Local Government Code, states that “Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”;

WHEREAS, the Municipality of Bayambang envisions to become a “globally competitive smart town with a transparent, accountable leadership and responsive community”;

WHEREAS, Bayambang is under a state of Revolution against Poverty that aims to uplift the quality of lives of the people of the municipality;

WHEREAS, sustaining peace and order is part of the sectoral goals under the Socio-cultural Development and Social Protection thrust of the Bayambang Poverty Reduction Plan 2018-2028;

WHEREAS, the Public Order and Safety Office was created through Executive Order No. 03, s. 2016 to “consolidate the varied public order and safety ordinances, resolutions, memorandums, programs and activities into one coherent directional policy and to focus one body specifically designed to meet the immediate long-term needs of the inhabitants on matters of general welfare and community service”:

WHEREAS, the POSO serves as a supplement to the Philippine National Police in the intensification of law enforcement;

WHEREAS, in the exigency of public service, there is a need to reorganize and change the name of the office in order to establish a new image for the renewed and improved POSO;

NOW THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, Municipal Mayor of the Municipality of Bayambang, by virtue of the powers vested in me by law, do hereby change the name of the POSO to **BAYAMBANG PUBLIC SAFETY OFFICE (BPSO)** which shall remain as the key municipal department in the implementation of laws and ordinances with regard to public order and safety. The BPSO shall maintain all its functions as mandated by E.O. No. 13, s. 2016 and shall maximize its manpower to instill discipline to the public, and trust and confidence to the LGU-Bayambang.

This Order shall take effect immediately upon signing hereof.
