EXECUTIVE ORDER NO. 45 *series of 2022*

DECLARING SUSPENSION OF CLASSES AT ALL LEVELS IN PUBLIC AND PRIVATE SCHOOLS AND SUSPENSION OF WORK IN ALL GOVERNMENT INSTITUTIONS DUE TO TYPHOON "FLORITA"

WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as "Local Government Code of 1991" provides that "every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective jurisdictions, local government units shall ensure and support, among other things, x x x promote health and safety x x x, maintain peace and order, and preserve the comfort and convenience of their inhabitants."

WHEREAS, Executive Order No. 66, series of 2012 which prescribes the rules on the cancellation or suspension of classes and work in government offices due to typhoons, flooding, other weather disturbances and calamities also delegated the authority to cancel classes and work to local chief executives of the affected areas of typhoons and other calamities.

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA) said that as of 23 August 2022, typhoon Florita has gained strength from a tropical storm category and upgraded into a severe tropical storm category and said that heavy to intense, with at times torrential rains, swept through much of northern Luzon, including Bayambang, Pangasinan.

WHEREAS, to protect Bayambanguenos, and to ensure the safety of our townspeople and allow them to make necessary preparation and arrangement to deal with the weather disturbance, there is a need to declare a suspension of classes at all levels in private and public schools and suspension of work in all government institutions.

NOW, THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, Municipal Mayor, Bayambang, Pangasinan, and chair of the Municipal Disaster Risk Reduction and Management Council, by virtue of the powers vested in me by law, do hereby order:

SECTION 1. *Suspension of classes in public and private schools and work in government offices in Bayambang, Pangasinan.* Classes in public and private schools in all levels and work in government shall be suspended on 24 August 2022.

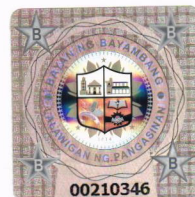
SECTION 3. Miscellaneous Provisions. All employees shall ensure that all office valuables are safe and secured to prevent fire, electrocution or damage.
