EXECUTIVE ORDER NO. 51

Series of 2022

REGULATING THE OPERATING HOURS OF THE BAGSAKAN AREAS IN THE MUNICIPALITY OF BAYAMBANG

WHEREAS, pursuant to Municipal Ordinance No. 01 Series of 2017 an Ordinance enacting a Market Code of the Municipality of Bayambang whose provisions shall govern the establishment, classification, administration, operation of Bayambang Public Market, imposition and collection of market rental fees for occupancy thereof;

WHEREAS, the power of general supervision and control over the administration and operations of the public market is vested in the Municipal Mayor including bagsakans;

WHEREAS, Executive Order No. 39 s. 2020 designated the Bayambang Tricycle Terminal as the bagsakan area for vegetables while the Pay Parking Area in front of the Municipal Plaza facing the Public Market (Block II) (Royal Supermarket) was designated to be the bagsakan area for fish products due to the declaration of State of Public Health Emergency under Proclamation No. 922 in response to the Covid-19 pandemic;

WHEREAS, the Inter-Agency Task Force Resolution No. 169-A dated June 27, 2022 placed Pangasinan under Alert Level 1 or the lowest Alert Level System wherein case transmission is low thus there is no issue to going back to the regular operations of the market while still maintaining a schedule for bagsakan for the wholesale of goods;

NOW, THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, by virtue of the powers vested in me by law as the Local Chief Executive, do hereby order that the **schedule of the bagsakan areas in the Bayambang Tricycle Terminal and the Pay Parking Area in front of the Municipal Plaza facing the Public Market (Block II) (Royal Supermarket) shall be from 1:00AM to 6:00AM only.**

All other existing schedules, particularly the bagsakan schedule of operation from 6:00 pm to 8:00 pm, is hereby amended and shall no longer govern the operation of the bagsakan;

If any provision of the Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby, shall remain valid and subsisting.

All other orders, rules, regulations and issuances, or parts thereof, which are inconsistent with this Order, are hereby repealed, amended or modified accordingly.

This Executive Order shall take effect at 12:00 midnight of 11 September 2022 and will continue until amended or revoked.
