AUTHORIZING THE TRANSFER OF APPROPRIATION UNDER THE MAYOR'S OFFICE

WHEREAS, THERE IS INSUFFICIENCY OF FUNDS IN THE APPROPRIATION OF MAYOR'S OFFICE CAPITAL OUTLAY-INFRASTRUCTURE PROJECTS REPAIR OF ESCALATOR OF PUBLIC MARKET;
