COMPOSITION OF THE TRAFFIC MANAGEMENT COUNCIL OF THE MUNICIPALITY OF BAYAMBANG

WHEREAS, Ordinance No. 8, series of 2010 known as "AN ORDINANCE ENACTING A MANDATORY TRAFFIC CODE IN THE MUNICIPALITY OF BAYAMBANG AND PRESCRIBING PENALTIES FOR VIOLATION THEREOF" was enacted on October 25, 2010;

WHEREAS, Article VII of the said Ordinance created the Traffic Management Council, which shall formulate plans and programs for the town's traffic system;

NOW THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, by virtue of the powers vested in me by law as the Local Chief Executive, do hereby order the Composition of the TRAFFIC MANAGEMENT COUNCIL for the Municipality of Bayambang, to wit:

Section 2. Functions and Responsibilities of the Traffic Management Council: The TMC shall perform the following duties and functions:

- a. Formulate plans and programs for the town's traffic system;
- b. Recommend to the Sanguniang Bayan any amendments on the Traffic Code;
- c. Adopt a Traffic Route and Management Plan;
- d. Act as Grievance Committee with jurisdiction over any and all complaints against traffic enforcers except those under the jurisdiction of the People's Law Enforcement Board (PLEB);
- e. Designate, assign and put up signs on designated Pay Parking Areas.

Section 3. Effectivity. This Executive Order shall take effect immediately and will continue to take effect until amended or revoked.
