MUNICIPAL ORDINANCE NO. 11, SERIES OF 2021

"AN ORDINANCE TRANSFERRING SOME PLANTILLA POSITIONS IN THE DIFFERENT OFFICES IN THE MUNICIPAL GOVERNMENT OF BAYAMBANG, PANGASINAN"

EXPLANATORY NOTE:

WHEREAS, Section 76 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirement and financial capability, subject to the minimum standard and guidelines prescribed by the Civil Service Commission;

WHEREAS, Section 447 (a) (vii) of the same Code provides that the Sangguniang Bayan has the power to determine the positions and salaries including allowances and other emoluments and benefits of employees of the municipal government;

WHEREAS, like any other dynamic organizations, the municipal government of Bayambang have to continuously adjust to rapid change-from a mere provider of traditional basic services, local government units will now assume more complex roles in socio-economic development and will continue to help shape the developmental directions of our country;

WHEREAS, innovations and reforms are needed to make our municipality more relevant, accountable, responsive and proficient that will meet the priority needs and to cope with the developmental plan, programs and objectives of the new administration;

WHEREAS, the primary purpose of transferring this plantilla positions is to designate the right employee(s) with the right skills, experience, competencies and fitness in order to perform their duties and responsibilities more effectively and efficiently;

NOW THEREFORE, on motion of SB Member Benjamin Francisco S. De Vera, duly seconded;


