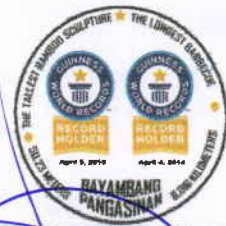

"RESOLUTION DECLARING OPERATIVE IN ITS ENTIRETY THE BARANGAY APPROPRIATION ORDINANCE NO. 02, SERIES OF 2021 OF THE BARANGAY ZONE IV, "AN ORDINANCE APPROPRIATE THE FUNDS FOR BARANGAY ZONE IV, BAYAMBANG, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P2,705,365.66"

Sponsored by all Municipal Councilors

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Bayan of Bayambang as a legislative body of the Municipality is empowered to review ordinances authorizing annual or supplemental appropriations of component barangays in the manner prescribed by law;

WHEREAS, received by the Sangguniang Bayan for appropriate action was the 1st Indorsement dated January 24, 2022 from the Municipal Budget Officer, forwarding the Annual Budget of Barangay Zone IV, this municipality, for Calendar Year 2022 as embodied under Barangay Appropriation No. 02, Series of 2021 involving the amount of **P2,705,365.66** with the information that this office rendered technical assistance in the preparation of the said annual budget and that they initially reviewed and found the same to have conformed with the existing budgetary rules and regulations and in accordance with the provisions of the Local Government Code of 1991;

WHEREAS, HOWEVER, the Sangguniang Barangay of Zone IV shall observe and comply with the following conditions:

- 1) That all programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2021 investment programs of the barangay, formulated Pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No.1, Series of 2007 dated March 8, 2007;
- 2) The utilization of the Appropriations from the 20% Development Fund shall be in accordance with the provision of DILG-DBM Joint Memorandum Circular 2011-2 dated April 13, 2011 specifically item 3.0 thereof;
- 3) That all procurement to be undertaken shall strictly be subject to the pertinent provision of the RA 9184 (The Government Procurement Reform Act) and its revise implementing Rules and Regulations;
- 4) Notwithstanding the above, the Budget is declared in operative in its entity, subject to the posting requirements under Section 59 of RA 7160. The barangay shall comply with the herein review findings and notify this office of the actions taken thereon;
- 5) That all other expenditures incorporated herein not specifically mentioned in the review conditions/action shall be governed by existing applicable guidelines/circulars/laws and issuances.

RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Bayan in session assembled, to declare operative in its entirety the Barangay Annual Budget for Calendar Year 2022 of Barangay Zone IV, Bayambang, Pangasinan involving a total appropriation of P2,705,365.65 as of the date fixed therein for its affectivity; provided that the disbursement of appropriations as approved shall be subject to the existing accounting and auditing rules and regulations, and compliance with other pertinent laws, rules and regulations shall be the responsibility of the Barangay Government of Zone IV and shall serve as basis for auditing purposes of the Commission on Audit;
